**STEP 3: Fees** - \$100.00 service fee includes filing the short form, cert. of dissolution, and the Election to Wind up and Dissolve + State counter fee is \$15.00. Total: \$115.00 + return shipping options. Rejected documents will incur additional state and service fees.

### SERVICE OPTIONS:

Add \$30.00 – Verify that the corporation is in good standing and is a domestic corporation. Corporations that are not in good standing cannot be dissolved until they are revived and good standing status is obtained. If the corp. is not in good standing or if the corporation is not domestic, the document(s) will be rejected. We will contact you by phone if the corp. is suspended or foreign.

Add \$50.00 for review document(s) for completeness\* AND verify that the corporation is in good standing and domestic to avoid rejection which can lose the file date and push the corporation into a new tax year. If document(s) is rejected, the cost to resubmit is \$53.00. If I choose this option and the document(s) is rejected after review, Sun will pay the \$15.00 state fee and will waive service and copy costs of \$38.00. Sun does not and cannot verify who the names of the authorized signers are. This is solely the client's responsibility to know who the Incorporator, officers, and/or directors are within the corporation. Rejection reasons that include incorrect signers are not covered and resubmittal fees will apply. (\*some restrictions apply – see our website for details).

**Our \$100.00 fee includes:** Filing your document with the Secretary of State the same day we receive your request in Sacramento (if before 2:00 PM PST and this form is completed correctly), writing required checks, making required copies, obtaining TWO certified copies from the Secretary of State, faxing the filed document(s), and returning the certified copies and payment receipt via regular mail. FedEx is additional. The state takes an average of 10-14 business days to file dissolution documents between November and January due to the increased volume of filers. The state takes about 7 business days from February through October. The document will be given the file date it was submitted on.
