**Our fee includes:** Filing your document with the Secretary of State on a 24 hour rush in Sacramento (if before 3:00 PM PST and this form is completed correctly), writing required checks, making required copies, obtaining either one plain copy or one certified copy from the Secretary of State, faxing or e-mailing your filed document, and returning the document via regular mail. FedEx is additional. \*\*Last run leaves to the state at 3:15pm PST. Orders received after 3:00pm will not be submitted until the following business day at 9:15am PST. The 24 hours will start at that time.\*\*
