Our fee includes: Filing your document on a rush basis with the Secretary of State the same day in Sacramento (if before 2:00PM PST and this form is completed correctly), writing required checks, making required copies, obtaining TWO certified copies from the Secretary of State, faxing or e-mailing your filed document, and returning the certified copies via regular mail. FedEx is additional. Note: The Secretary of State will complete the filing within 24 hours after they receive it. The document will be given the file date it was submitted on. Corporate numbers are not available until the filing is complete. Please allow 24 hours plus run/copy/fax/scan time (1-2 hours depending upon the time the document is returned) before calling and checking on your document.
